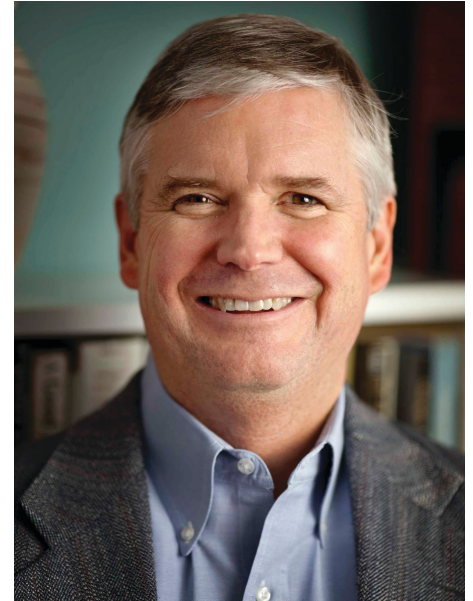

OPENING REMARKS

MAYOR JOHN HAMILTON

John Hamilton has served Bloomington residents as their Mayor since January 2016. He brings to the office a history of and a commitment to improving the quality of life for all in the community, with a particular focus on sustainability and inclusivity. In collaboration with City Council, Mayor Hamilton has helped coordinate an unprecedented series of advancements in Bloomington:

- New revenue and programs have made Bloomington Indiana's only city with a nationally accredited police department (CALEA) and a top-rated fire department (ISO 1/1x), with declining crime rates and 6 years of no fire fatalities
- More than 1,100 new affordable housing units have been approved, a twenty-fold increase from previous years, including units for people experiencing homelessness, mental illness or disability, as well as our growing workforce
- Wages in Bloomington have been rising faster than in most Indiana communities, with thousands of new jobs following more than \$3.5 billion in new investments over the past 5 years, and the state's fastest-growing co-work space
- The first Climate Action Plan sets a goal of carbon-neutrality by 2050, reducing greenhouse gas emissions by 25%, and actively working toward mitigating climate change and increasing our resilience through more efficient infrastructure and sustainable development. This includes solar power, trails as transportation corridors, innovative waste and wastewater systems, and new \$1.6MM annual funding for progress
- A commitment to diversity, equity, and inclusion with a Racial Equity plan and two new resident-led task forces to evaluate, report, and propose recommendations to address racism and discrimination in Bloomington



Since 2020, Bloomington and Monroe County have navigated the global pandemic with exceptional collaboration among government and the civic and private sectors, helping the community experience some of the lowest rates of COVID-19 infection and mortality in the state.

Mayor Hamilton previously served as the Secretary of the Indiana Family and Social Services Administration, the Commissioner of the Indiana Department of Environmental Management, and advisor to Governor Frank O'Bannon. John also co-founded and directed Washington, D.C.'s City First Bank, dedicated to strengthening low-to-moderate-income communities.

Mayor Hamilton was born in Bloomington, where he and his wife Dawn Johnsen, a distinguished legal scholar and nationally recognized advocate for women's rights and the rule of law, raised their two sons. Hamilton is an honors graduate of Harvard University and Indiana University Maurer School of Law.

OPENING REMARKS

MAYOR JIM LIENHOOP

James D. Lienhoop is the 37th Mayor of the City of Columbus, taking office on January 1, 2016. Although newly elected as Mayor, he served City government since 2006, beginning as an interim member of City Council to replace a council member who was called into active duty overseas. He was elected to his own term as Columbus City Councilman, an at-large representative in 2012.

Columbus is ranked sixth in the nation for innovation and design by the American Institute of Architects, with buildings and public art installations created by Eero Saarinen, Harry Weese, Kevin Roche, I.M. Pei, Henry Moore, and Dale Chihuly. National Geographic Traveler has Columbus at the top of their list of the United States historic destinations.

Columbus is also the world headquarters for Cummins Inc., a Fortune 500 Company and diesel engine manufacturer and home to specialized industries such as transportation and automotive equipment manufacturing, fabricated metal product manufacturing, plastics and rubber product manufacturing, and paper product manufacturing.

The Leinhoop Administration is actively working in four areas to make Columbus even greater.

Public Safety: BackgroundChecks.org, an organization devoted to public safety and open government has ranked Columbus as one of the 25 safest cities in Indiana. Over the last several years, our violent crime rate has been one-third to one-half of the national rate.

Economic Opportunities: The City's relationship with the Columbus Area Economic Development Board will be enhanced by making a greater investment in targeting the pharmaceutical, engineering research, and development and administrative support industries.

Educational Attainment: Columbus Redevelopment Commission will assist Bartholomew Consolidated Schools with funds for programs designed to improve graduation rates and better prepare our graduates for the kind of jobs we'll see in the next decade.

Relationship Building: We will work to strengthen relationships with several key stakeholders, including other communities, state government, and City Hall employees.

Jim has been heavily involved in the Columbus community, having served on the board, usually in an officer capacity, of numerous not-for-profit endeavors.

A life-long resident of Columbus, Jim has been married to his wife, Pam, for over 30 years. Together they have two children, Jon and Libby.



KEYNOTE

TOM LINEBARGER **EXECUTIVE CHAIRMAN OF CUMMINS INC.**

Tom Linebarger was appointed as Executive Chairman of Cummins Inc. in August 2022. In this role, Tom will continue serving as Chairman of the Board.

Prior to this role, Tom served as Chairman and Chief Executive Officer (CEO) for 10 years. Before that, he served as President and Chief Operating Officer from 2008 to 2011, Executive Vice President and President, Power Generation Business from 2003 to 2008, Vice President and Chief Financial Officer from 2000 to 2003, and Vice President of Supply Chain Management from 1998 to 2000.

Tom was initially attracted to Cummins' purpose-driven approach to business. That was reinforced during a summer internship at the Cummins MidRange Engine plant in Walesboro, Indiana (USA). He liked the values, the people and the business challenges he found at Cummins and decided to join full time in February 1993. Prior to Cummins, Tom was an investment analyst and investment manager at Prudential Investment Corporation, working in both Singapore and Hong Kong.

In addition to his work at Cummins, Tom is actively involved with several global and local organizations. He has been a member of the Board of Directors of Harley Davidson since 2008. He is a member of the Business Roundtable (BRT), an association of chief executive officers of America's leading companies working with government officials on crafting legislation impacting American businesses. In 2021, Tom was appointed Chair of the Central Indiana Corporate Partnership (CICP) and Co-Chair of the Global Hydrogen Council. Tom previously served as Chair of the U.S.-China Business Council from 2020 to 2022.

Tom grew up in California and received joint undergraduate degrees in management engineering from Claremont McKenna College and mechanical engineering from Stanford University. He later returned to Stanford University to earn a master's degree in manufacturing systems from the School of Engineering and a master's degree from the Graduate School of Business.

Tom and his wife, Michele, have two adult daughters, Alex and Emily, and enjoy traveling to spend time with them.

Gabriel Filippelli is an American biogeochemist and Chancellor's Professor of Earth science at Indiana University-Purdue University Indianapolis (IUPUI). He also serves as the Executive Director of the Indiana University Environmental Resilience Institute and Director of the Center for Urban Health at IUPUI. His research interests include biogeochemical cycling in the environment, and the impacts of climate change on the environment and human health, including human exposures to harmful environmental components. He was awarded a BS in Geology from the University of California, Davis in 1986 and a PhD in Earth Science in 1994 from the University of California, Santa Cruz.

Gabe has been a member and Chair of the United States Advisory Committee for Scientific Ocean Drilling and of the Science Planning Committee for the International Ocean Discovery Program. He has also written for a variety of major journals, including Nature, Science, and Geology, among others. He currently serves as Editor-in-Chief for GeoHealth.

He served as senior science advisor for the United States State Department from 2013-2014, working in the area of ocean and polar science policy. He has also served as an Air Quality Fellow for the US State Department and consults with embassies and universities in Pakistan on air quality science.

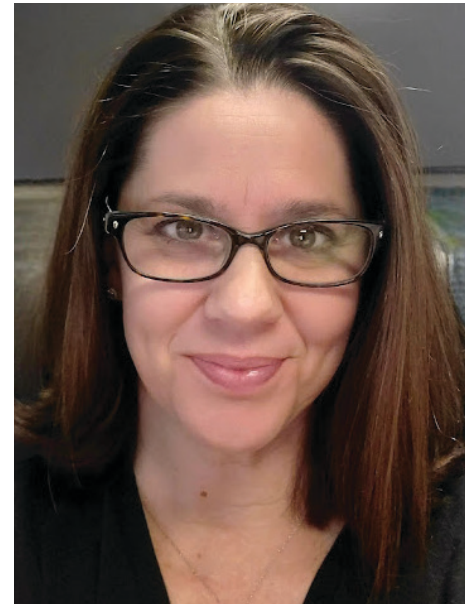

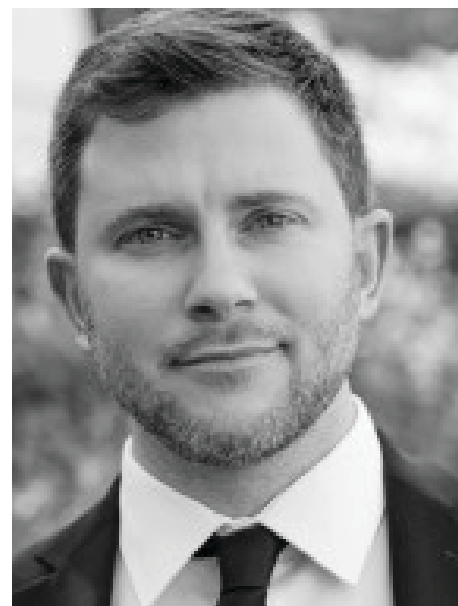
DANIEL POYNTER

Daniel Poynter grew up in a small town near Fort Wayne and studied philosophy at Purdue University.

He worked as an engineer for a decade then, in 2019, took a sabbatical to interview 300 people working on the environment in the Midwest. From this year of research, he created the nonprofit Carbon Neutral Indiana. They have three programs. First, they've helped over 600 Hoosier households measure their carbon footprints. Second, they sponsor Climate Solutions Reporters at Purdue. And finally, they published a book called *Carbon Neutral Indiana: A Practical Guide for Climate Optimism*.

Daniel was named a MacArthur Foundation Young Innovator, he's advised over 100 entrepreneurs, and has been invited to speak at academic institutions throughout the world like Brown, Cornell, and Stanford.
